TERMS & CONDITIONS OF ENTRY

By entering the MotorEx Unveiled competition you are agreeing to the following Terms & Conditions:

1. GENERAL TERMS

1. Information on how to enter MotorEx Unveiled (Competition) and prize details form part of these Terms & Conditions of entry.
2. Participation in the Competition constitutes acceptance of these conditions of entry. Entrants must comply with these Terms & Conditions of entry to be valid.

2. PROMOTER'S DETAILS

1. The promoter is Out There Productions Major Events Pty Ltd (ANB 12 152 488 821) of PO Box 1329, Kingscliff NSW 2487 (Promoter).

3. WHO CAN ENTER

1. The competition is open to any one that purchases a Meguiar's MotorEx presented by REPCO (Event) spectator ticket up until **11:59am Australian Eastern Daylight Time (AEDT), Thursday 27th April 2023**.
2. You must have a valid Event spectator ticket to redeem any of the prizes.
3. Employees of the Promoter or the Promoter's associated agencies or companies directly involved in the Competition and their immediate family members are ineligible to enter.

4. HOW TO ENTER

- 4.1 **The Competition commences on Wednesday 5th April 2023 at 11:00am AEDT and entries close on Thursday 27th April 2023 at 11:59am AEDT (Promotional Period).**
- 4.2 To enter this competition, you must have a valid Event spectator ticket by purchasing a ticket directly through the Event website, <https://motorex.com.au/>
 - A. A competition entrant is defined as a purchaser of an Event ticket and providing a minimum of a name and email address upon purchase
 - B. Entries before the Competition Promotional Period have an automatic entry.
 - C. Entries are limited to one (1) per ticket purchased.
